### **IMPORTANT NOTE**

#### **A. Documents to be produced at the time of Document Verification.**

The candidates shortlisted for verification are required to submit ORIGINAL documents along with two (02) sets of duly Attested/Self-Attested photocopies of the following certificates/documents on the day of verification in support of their eligibility for the post:

- i. Proof of Date of Birth – Matriculation/Secondary Certificate or equivalent.
- ii. Certificates/Mark Sheets in support of Essential Educational / Technical / Professional Qualification as prescribed for the post.
- iii. Registration Certificate with the concerned Council, wherever required.
- iv. Experience Certificate, wherever applicable.
- v. Category Certificate issued by the Competent Authority in the prescribed format in respect of candidates belonging to SC / ST / OBC / EWS / Ex-Servicemen.
- vi. Disability Certificate, in case of candidates applying under PwBD category.
- vii. Certificate for age relaxation, wherever age relaxation has been claimed on grounds other than Caste / PwBD.
- viii. Candidates claiming reservation under SC / ST / OBC / EWS / PwBD / Ex-Servicemen must be in possession of valid certificates in the prescribed format of Government of India, as per eligibility conditions mentioned in the detailed advertisement.
- ix. No Objection Certificate (NOC) in respect of ESIC Employees / Central Government / PSU / Autonomous / State Government Employees, along with Relieving Order before joining, if selected.
- x . Two (02) passport size photographs.

- xi. Copy of downloaded registration slip of the online application form.
- xii. Copy of Admit Card / Call Letter / Email for document verification.
- xiii. Photo bearing Identity Proof (self-attested photocopy along with Original) viz. Aadhaar Card / PAN Card / Voter ID Card / Passport issued by the Government.
- xiv. Affidavit, wherever required, in case of mismatch of Name / Father's Name / Surname etc. in various documents.

All documents/certificates must be strictly in accordance with the eligibility criteria and prescribed format as published by AIIMS, New Delhi vide Notice No. 268/2025 dated 22.07.2025.

## B. General Instructions

1. Failure to report at the venue of Document Verification on the scheduled date and time may tantamount to rejection of candidature.
2. Candidates who fail to produce Original Documents, including valid category certificates (OBC / EWS / SC / ST / PwBD) or any other document as per eligibility criteria during document verification, their candidature shall be cancelled and the allocated seat will be forfeited.
3. No Travelling Allowance or any other expenses for attending the Document Verification shall be admissible by the Corporation.
4. Mere calling of a candidate for Document Verification does not confer any right for appointment to the post advertised.
5. The candidature is purely provisional and subject to satisfaction of all eligibility conditions.
6. If at any stage it is found that the candidate has appeared through proxy or indulged in any malpractice, appropriate action as deemed fit shall be taken by ESI Corporation.
7. Candidates must carefully verify their eligibility as per the published eligibility criteria for the respective category (including PwBD) before reporting for Document Verification.
8. Candidates must carefully review their eligibility as per published eligibility criteria for respective applicable category (including PwBD) for the post / institute before reporting. If the candidates are found ineligible at any stage (e.g. due to age, qualification, experience, category certificate or any other condition), their candidature will be summarily cancelled, even if they have been provisionally allocated a seat. In such cases their selection will be treated as void ab initio.
9. All procedures, conditions and requirements relating to Document Verification and eligibility shall be followed strictly in accordance with the **Recruitment Notice issued by AIIMS, New Delhi vide Notice No. 268/2025 dated 22.07.2025** and instructions issued thereunder. Any issue not specifically covered herein shall be regulated as per the provisions contained in the said notice
